Minutes of Regular Meeting Mayor and Council City of Fitzgerald, Georgia July 9, 2018 6:00 pm

Mayor and Council of the City of Fitzgerald, Georgia, met in a *Regular* meeting in the City Hall Council Chambers, located at 302 East Central Avenue, with Mayor Pro Tem Griffin presiding and with Council members Coney, Jefferson, Johnson, Roberts, Tillman, Webb and Williams being present.

Minutes of June 11, 2018, Regular Council meeting were read. Mayor Pro Tem Griffin entertained a motion for approval. Council Person Williams made a motion to approve minutes, seconded by Council Person Coney. Having a motion and a second, Mayor Pro Tem Griffin asked if there were any additions or corrections. Council Person Johnson motioned to accept this reappointment seconded by Council Person Coney. Mayor Pro Tem Griffin asked if there was any discussion.
