A Public Hearing took place at the City Hall Council Chambers, located at 302 East Central Avenue, on Monday, September 14, 2020.

A **Public Hearing** was held to give consideration to application number 0129 by RUC Fitzgerald LLC, for an amendment of the Zoning Ordinance for the City of Fitzgerald. This property is located at 125 Benjamin H Hill Dr SW. to rezone 1.44 acres of said property from GB County to GB City. With no discussion the public hearing was closed.

Hill drive, Fitzgerald, GA 31750, and the public road right of way adjacent thereto; to annex said property to the existing corporate limits of the City of Fitzgerald, Georgia; to rezone said property from G-B County to G-B City.
