Minutes of Regular Meeting Mayor and Council City of Fitzgerald, Georgia September 11, 2023 6:00 p.m.

A Public Hearing was held to receive citizens input on the **2023 tax levy** for the City of Fitzgerald. With there being no one to speak, the public hearing was closed.

Mayor and Council met on Monday, September 11, 2023, at 6:00 p.m. at the City Hall Council Chamber, located at 302 East Central Avenue, with Mayor Jason L. Holt presiding and with Council members Brown, Clemons, D. Jefferson, S. Jefferson, J. Johnson, K. Johnson, Roberts and Webb being present.

Mayor Holt welcomed everyone and apologized for the warm, cozy environment.

Mayor Holt brought to the attention to the fact we need to amend the agenda as the date for the minutes was incorrect. The minutes were dated for July 24, 2023, and it should have been August 14, 2023. A motion was made by J. Johnson to accept the amendment to the agenda and seconded by Roberts. With there being no discussion, Roll Call Vote: 8 Yes, 0 No. All in favor, motion approved.

Minutes of previous meeting August 14, 2023, Regular Council meeting were presented. Mayor Holt entertained a motion for approval. Council member J. Johnson made a motion to approve minutes, seconded by Council member Roberts. With there being no additions or corrections, Mayor Holt called for a *Roll Call Vote: 8 Yes, 0 No. All in favor, motion approved.*

Under hearing from citizens or visitors, Mayor Holt called on Walter Barineau. Mr. Barineau is the real estate director for the new Waffle House that will be coming to Fitzgerald. Mayor Holt thanked him for investing in our community.

Under **reports of city officers**, Mayor Holt called attention to the Administrative Report, sharing some highlights from each department.

Council Person S. Jefferson asked about vendor permits for the fall festival. She was directed to the tourism office or can call 229-423-5033.

Mayor Holt called on Thomas Holt to come and make a presentation. Thomas Holt spoke about the 22nd Anniversary of 9-11. He is a junior at Tift Area Academy and the 23-24 State Board President for the 4-H Club. He saw in the community a lack of civic engagement so he and many volunteers lined Main Street this year with 1,040 American Flags to help commemorate 9-11 and show patriotism and unity.
